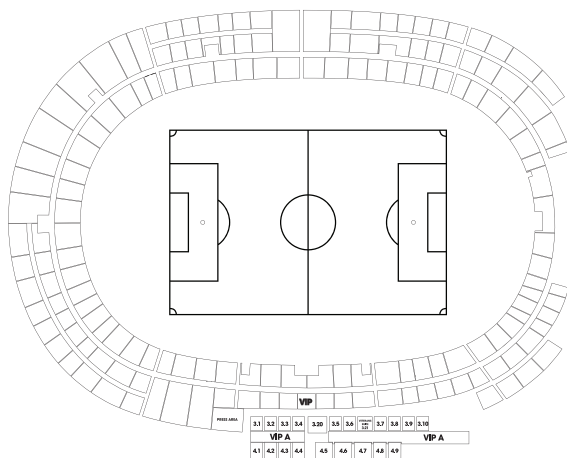

Toumba Stadium was built in 1959 for the club's sporting venues and served also as the home ground for the club's football team, which was participating in the then national football league. Since 1979, has also served as the home ground of PAOK Thessaloniki FC. The stadium is located in the Toumba district of Thessaloniki. Its capacity was originally about 40,000, until the installation of seats on all stands in 1998 reduced capacity to 32,000 (seated). The introduction of security zones in 2000 further reduced the capacity to the current 28,703 seats. Record attendance is 45.252 in a 1st division football match between PAOK and AEK on 19.12.1976. Its official name is simply "PAOK Stadium". However, it is commonly referred to with the name of the district in which it stands. Toumba Stadium has hosted a few games of the Greece national football team.

The stadium was selected as one of the training venues for the football tournament of the 2004 Olympic Games. This meant that it had to be upgraded. The relevant works commenced in 2003 and the stadium was again ready to be used in the summer of 2004, boasting a brand new look. The most important modification was the construction of a new four-storey building behind the main west stand (gates 1, 2 and 3). This houses a number of VIP boxes and a VIP lounge, service areas for the TV and the Press, new club offices etc. A new roof was also installed over the west stand. Other works that took place included new seats, upgrading of dressing rooms, new pitch and re-enforcement of the concrete pillars below the north curved stand (gates 4 and 4a).

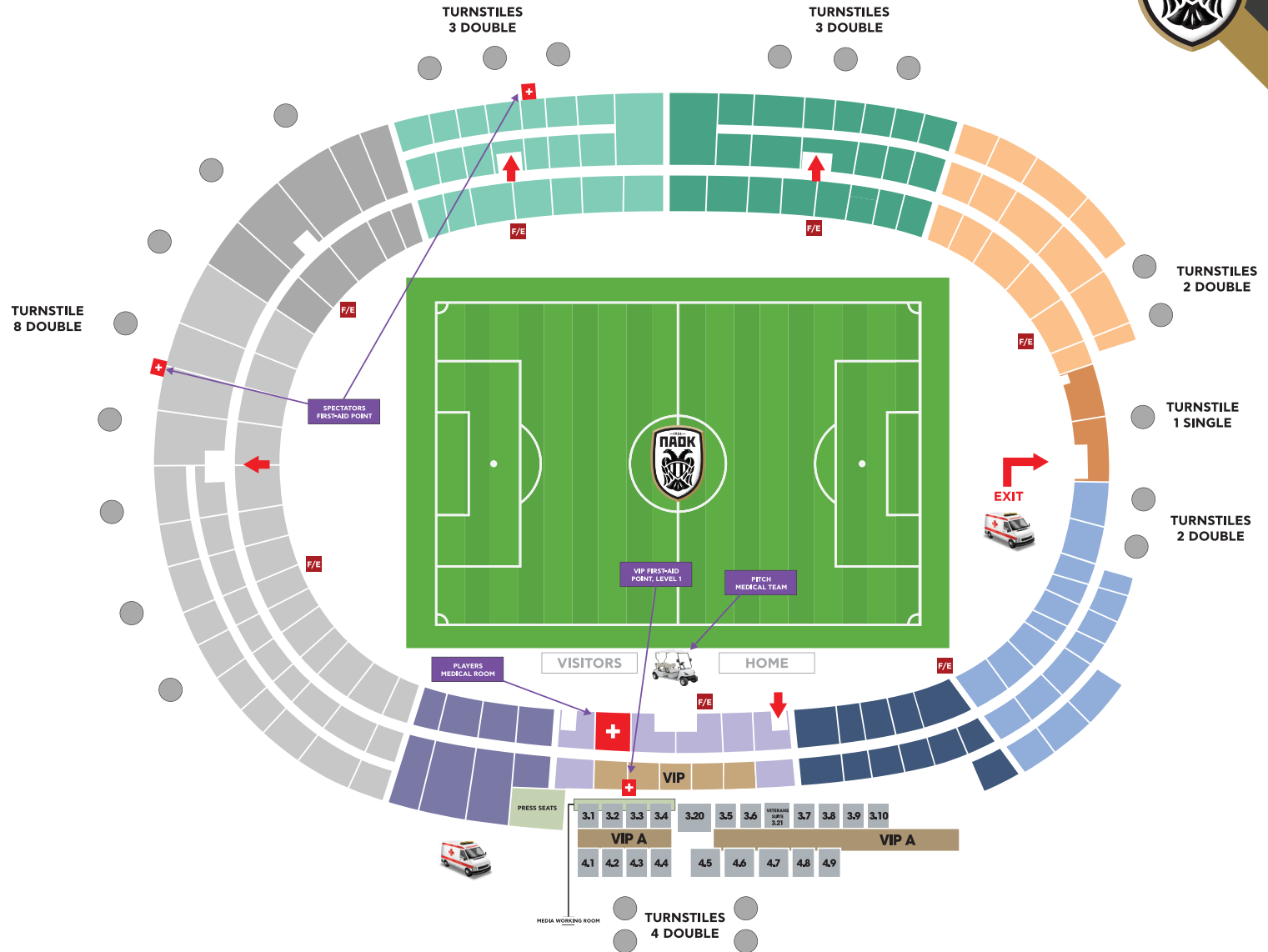

TOUMBA STADIUM GROUND REGULATIONS



Entry and stay in Toumba's stadium is subject to compliance with the following regulations.

1. Each holder of ticket or accreditation is considered to have been informed of the internal regulation of safety and accepts the regulation of the stadium and the regulation of the Hellenic Football Federation as well as of the Organizer.
2. As stadium is considered the total ground including all building group, part or parts of the adjacent infrastructure.
3. All matches will be held within the frame of the respective regulations of the Hellenic Football Federation and of the Organizer and generally of the sports legislation
4. Each visitor presenting himself in the entrance of the stadium must hold either a valid entrance ticket or a valid accreditation granted by the Organizer which allows the entrance. The ticket is valid for one and only use. Each person in the stadium must at any moment bring with him his ticket or accreditation.
5. The movement to another gate or to another area of the stadium without the consent of the steward or officer or other authorized person of PAOK FC is not allowed.
6. The spectators must be seated on the seat defined on their ticket unless otherwise suggested by the stewards or a representative of the Club.
7. Each visitor enters the facility on his own responsibility against possible theft in the stadium.
8. In case of postponement or suspension of the match the refund of the entrance fee is subject to the discretion of PAOK FC. In any case, visitors should keep their ticket.
9. The club has the right to prohibit the entrance or expel from the stadium anyone denies to be subjected to security body search by the stewards or the police.
10. It is not allowed to bring in the stadium:
Fireworks, rockets, hand-held flares, smoke powder, smoke bomb, signal rockets and other pyrotechnics, flagpoles, laser pointers, bottles and generally any other items of a nature suitable and intended to cause injury or damage.
11. The following actions are prohibited:
 - Throwing of objects on the field.
 - Performing gestures or shouting slogans and paroles which aim to discriminate people according to skin colour, religion, ethnicity, sex, or sexual orientation in both content and form.
 - Unauthorized entry within the pitch.
12. The use of alcohol or other by law prohibited intoxicating substances is not allowed.
13. Emergency exits, doors, aisles and stairways must not be blocked, locked or have their function changed in any way. Visitors are prohibited to try to climb up the lighting installation of the stadium, the stands or other structures of the stadium.
14. Any unauthorized person attempting to gain access without an accreditation to an area of the stadium without the approval of the administration will



be expelled from the stadium.

15. The production of photo, audio, video, or other media material for any use as well as making, copying, broadcasting and using image and sound recordings of visitors in any audiovisual media without express prior permission of the event organizer is strictly forbidden. Transmission, production of images and reproduction of the event in any way, including the Internet and mobile phones, is prohibited.

16. The sales of wares of any kind, the distribution of print material, collections, magazines, flyers, advertising material etc. inside the facility grounds is strictly forbidden, unless previously agreed upon with PAOK FC administration.

17. Any person damaging the property of the Club or the Stadium, will be prosecuted.

18. Spectators not following the instructions of the stewards, the police or authorized representatives of the Club will be expelled.

19. The administration of PAOK FC reserves the right to expel from the stadium any person who does not comply with the regulations or whose behavior causes problems or increases general danger for the visitors.

20. The administration of the Club is obliged to hire authorized persons (stewards, security officers etc.) being easily identified which in cooperation with the local authorities are instructed to do a security check and disallow any forbidden items.

21. The administration of PAOK FC is obliged to check the content of the banners being displayed by the fans in order that their content is not improper, racist or insulting persons or groups of people.

22. The authorized persons of PAOK FC or the stewards can transfer or remove any banner or flag that makes difficult to the other visitors to watch the match.

23. The visitor acknowledges that for safety and security purposes the entire facility is equipped with security cameras that monitor at all times everything taking place inside the stadium (CCTV). For this reason the deliberate cover of the face of the visitor intended to prevent the establishment of a person's identity is not allowed.

24. PAOK FC reserves the right to expel for a specific period any visitor whose behavior deemed inappropriate and depending on his action to cancel his season ticket (if he is a holder). If in this period the specific visitor will try to watch a match, the period of the expulsion will be updated and doubled.
